

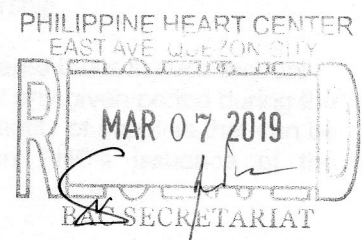

**ANTECEDENTS:**

The SUPPLIER is engaged in the sale of **Pharmaceutical items;**

PHC is in need of pharmaceutical items and is authorized to purchase the same pursuant to Sections 5(1) and (2) of PD 673, Series of 1975;

In response to the advertisement at **Philippine Star on October 12, 2018,** the SUPPLIER and other suppliers/bidders submitted their bids for the supply of pharmaceutical items to PHC;

Considering that the SUPPLIER's offer is the lowest, most beneficial and advantageous to PHC, the latter thus awarded the Contract in favor of the SUPPLIER;

ACCORDINGLY, premises considered, the parties hereby agree as follows:

**1. ITEMS TO BE PURCHASED & PURCHASE PRICE**

Items to be purchased by PHC from the SUPPLIER, with the respective cost per unit thereof are specified in Annex A (consists of 2 pages), which is made an integral part hereof. All purchases shall be covered by Purchase Orders.

The quantities stated in Annex A pertain to the total and maximum amount which PHC may purchase throughout the Contract duration. PHC may purchase a lesser amount/ quantity as may be determined by the actual need and consumption of the hospital.
