II. Other matters

- 1. Result of the final evaluation of the Product, re: N95 Respokare; Distributor: IDS Medical System Philippines
 - As per Product Standard's (PS) evaluation via their Routing Slip to BAC received at BAC Office dated March 26, 2021; item N95 Respokare stated DENIED.
 - It was specified and reiterated by Ms. Rachelle Cortez that as per our requirement stated in the bidding documents, it is stipulated that all items or product should undergo evaluation and approval by the PS prior to joining bidding at PHC. Having this statement, it is presumed that all items or products joining the bidding have passed PS evaluation.
 - It was noted that IDS Medical System failed to secure the approval/evaluation of PS prior to joining the bidding held last January, 2021. Thus, the item was awarded to IDS Medical System.
 - RESOLUTION:
 - 1. To seek inquiry from the Product Standard as to the period of submission of IDS Medical System specifically for N95 Respokare.
 - 2. Product Standard to specify reason/s of non-acceptance/Denial of the product.
