# 1. Percentage of Bidded Pharma Supplies for FY 2021 (1st Bidding) – c/o Ms. Imelda Viena, End-user.

- According to Ms. Viena, only 38% of the Pharma Supplies was successful, she is requesting for re-bidding.

- Also according to Ms. Viena, factors affecting the low percentage are:
  - \* only few bidders
  - \* few pharma supplies are not included in the PHC Formulary; and Others pharma supplies were not yet evaluated yet by the Therapeutics Committee.
- It was also noted that the INSTRUCTION FOR PRODUCTS TO UNDERGO EVALUATION by the Therapeutic Committee is indicated in the bidding documents.

## 2. Benchmarking of Bidding Fees, re: Pharmaceutical Supplies.

- As per review of the statement from the bidding documents bidding fee, shall be revised to make it more understandable.
- Atty. Manalang was reached via telephone call facilitated in by the Chairman to inquire ≠ on the validity of the practice of PHC wherein both of the DISTRIBUTOR AND PRINCIPALS are required to pay bidding

fees. Thus, it was agreed by the BAC Members and TWG that starting y2021, all bidding fees shall be shouldered by the DISTRIBUTOR and that PAYMENT WILL BE PER CATEGORY.

- Notice of Award shall also indicate ONLY the DISTRIBUTOR.
- 3. Motion for Reconsideration filed by Medilines Distributors, Inc. relative to the Project, re: 1 Unit Cardiac Catheterization Laboratory Equipment (Angiogram Machine).
  - Mr. Livy Magno of CV LAB was invited to attend the discussion on the MR. He was also present during the Online Demonstration held on December 18, 2020 along with Dr. James Ho. Ms. Velasco asked Mr. Magno to talked about what had transpired during the online demonstration by Medelines Distributor, Inc. for the Bi-plane equipment claimed to be the state-of-the art bi-plane of SIEMENS. It was noted that the person who did the demonstration is based in Singapore and that they also claimed the reason why the equipment used is not for the CARDIAC but of NEURO.
  - Mr. Magno further said that based on the items specified in Technical Specifications which was marked NON-COMPLAINT is because it was not seen or shown during the demo specifically the live coronary guidance and road mapping. He affirmed that what was stated in our report of the Post Qualification Process was valid.
  - The BAC hereby stick to the previous decision, thus MR is DENIED.
