Other matters:

- MR filed by Saviour MeDevices, Inc. relative to the Project, re: 1 Unit High End Echo Machine with 3D/4D and Strain Imaging Capabilities.
 - The Project was handled by BAC, Mr. Rex Garde and TWGs, Ms. Magallanes and Engr. Eoy.
 - The End-users, Ms. Senga and Ms. Vallarta were invited.
 - A Routing Slip signed by Dr. Berwyn Flores was read and indicated its reasons for the denial of the MR of Saviour MeDevices.
 - As per the RS, as mentioned by Ms. Velasco, there was response and justification from Saviour MeDevices vis-à-vis to several items in the Technical Specifications which was found out to be non-compliant.
 - Item on fully automated aortic and mitral valve analysis. The mitral valve analysis part was found out to be not fully automated and was signified by Saviour MeDevices.
 - Dr. Pascual also stated the contention of Saviour MeDevices being the specific item as endorsed by the American Society of Echocardiography however he adheres to the preference of the Endusers.
 - Mr. Garde also added that Saviour MeDevices failed to coordinate with the Noninvasive Cardiology Division, in terms of connectivity and integration in the system.
 - It was also noted that Saviour MeDevices provided Certifications to specific items however was not fulfilled during the actual demo/post qualification.
 - RESOLUTION: MR denied.
 - Endorsement for re-bid. Ms. Senga stated that they have to add an item in the Technical Specifications.
- Cancellation of the Project, 1 Unit Automated External Defibrillator (AED) the ABC is too much for the said Project. There were suppliers who can offer as much as P110,000.00 to P150,000.00 only and can be procure through Alternative Mode of Procurement.
- 3. Schedule for detailed bid evaluation to be determined by TWG Chairman, Marcial Magleo.
