III. Other matters:

- Results of the Post-Disqualification process of Southside Biomedical Sales and Services Bidder 2
 pertaining to the Project, 3 Units High Flow Nasal Cannula submission of lacking documents c/o TWG.
 - As reported by the TWG Chairman Mr. Magleo, detailed bid evaluation was already conducted thus few documents/certifications was not found.
 - Consensus of the TWG FAILED and proceed with the next Lowest Calculated Bid.
- 2. Results of the Re-Bid, re: Pharma Supplies
 - 2.1. Globo Asiatico, Inc. with deficiencies in price and quantity.
 - As reported by Ms. Sarmiento, the drug concerned (Herceptin) as bidded by Globo Asiatico was computed to a one year supply (January-December, 2021) when in fact, what was stated in the bidding documents was from April December, 2021 only.
 - Ms. Velasco verified with Ms. Sarmiento regarding the movement of Herceptin to our Institution.
 Ms. Sarmiento reiterated that with the current health status (pandemic), less cancer patients are being admitted to PHC.
 - Ms. Velasco gathered the consensus of the group whether to consider or not Globo Asiatico with Herceptin.
 - Mr. Rex Garde also added that the need or demand for Herceptin with the current situation is not much.
 - Ms. Agnes Balid also added that patients can seek assistance from the Malasakit Center and is usually referred to Globo Asiatico for the same medication.
 - RESOLUTION: FAILED
 - 2.2. Prime-Medix not PTC approved.
 - During the detailed bid evaluation, it was found out that the PRIME Medix failed to seek approval from the PHC Pharmacy & Therapeutics Committee.
 - RESOLUTION: FAILED
