- 1. Status of the Medical Supplies Project Alvin Rey De Leon, Frank Lagon, Maritess Perez (Budget). Abstract of Sealed Bidding for Medical Supplies is already available. For advertisement
- Issues and Resolution:

Overall Total ABC (1.9 Billion) is higher on the APP Cy2021 (514M – medical supplies). As per Ms. Perez, 39% of our budget is dedicated for medical supplies as projected/forecasted based on our income. While Mr. De Leon had considered the actual consumption, unit cost, plus the CoVid

demand and 70+ bed.

Dr. Flores suggested that entries should be categorized, as to the effects of CoVid and CoVid

essentials and its related supplies from the regular supplies.

Ms. Cortez further give feedback on the timeline, re: EPA and its effect to no compliance. No PBB. Ms. Perez suggested to have the other items to consignment, since it has a bigger budget.
