WHEREAS, after the detailed offer evaluation on October 12, 2015, resulted in the following:




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- b). To recommend for approval by the Executive Director of the Philippine Heart Center the foregoing findings.


