## INVITATION TO SUBMIT LEASE PROPOSAL

## Terms and Conditions:

- 1. The project/s is either a five (5) year or two(2) year term lease.
- 2. A cash deposit equivalent to two (2) months and one (1) month advance rental shall be paid by the lessee.
- 3. Rental shall have an escalation rate of five percent (5%) on annual basis starting on the 3<sup>rd</sup> year for the contract covering five (5) years.
- 4. All taxes and notarial fees shall be borne by the lessee, except for Real Property Tax (RPT).
- 5. Other terms and conditions shall be referred to the PHC Lease Guidelines.

All interested parties may secure lease proposal forms starting **February 10, 2021** from the Accounting Division (to look for Mr. Gerald Rabe, CPA), Basement, Medical Arts Building.

All sealed proposals must be submitted in triplicate copies to the PHC Rentals Committee on Wednesday, **February 24, 2021** at **2:30 P.M**. (Ampitheater, 5<sup>th</sup> Floor, Medical Arts Building) after which all offers will be opened in the presence of the bidders.

The PHC reserves the right to disqualify any prospective bidder(s) if found that they have submitted falsified documents and/or information. It shall also have the right to accept or reject any offer, and to annul the process and reject all offer at anytime prior to award of lease, without thereby incurring any liability to the affected bidder(s), if the lease shall be found to be disadvantageous to PHC.
