Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Revised Implementing Rules and Regulations Part A (RIRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" and is restricted to Filipino citizens/sole proprietorship, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens rights and to citizens of the Philippines, and to citizens or organizations of a country the laws and regulations of which grant privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A.5183) and subject to Commonwealth Act 138 (C.A. 138). Only bids from the Bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, ITB. The bidders with the Lowest Calculated/Rated and Responsive Bid (LCRB) shall advance to the Post-Qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the Project. The contract shall then be awarded to the Lowest Calculated/Rated and Responsive Bid (LCRB) who was determined as such during the Post-Qualification procedure.
