- 2. The PHILIPPINE HEART CENTER now invites Offers from eligible Bidders for the above Goods & Services. The description of eligible Bidder is contained in Section II of the Bidding Documents, ITB.
- 3. Bidding will be conducted through negotiated procurement procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act" and is restricted to Filipino citizens/sole proprietorship, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens rights and to citizens of the Philippines, and to citizens or organizations of a country the laws and regulations of which grant privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A.5183) and subject to Commonwealth Act 138 (C.A. 138). Only offers from the Bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, ITB. The bidders with the Lowest Calculated Offers (LCO) shall advance to the post- qualification stage in order to finally determine responsiveness of the offer to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Offer (LCRO) who was determined as such during the post- qualification procedure.
- 4. Interested Bidders may obtain further information from PHILIPPINE HEART CENTER, Bids and Awards Committee, East Avenue, Diliman, Quezon City, and inspect the Bidding Documents at the address given below from 8:00 a.m. to 4:00 p.m. Monday to Friday, except during holidays, Saturdays and Sundays.
- 5. A complete set of Bidding Documents must be purchased by interested Bidders, from the address below and upon payment of a non-refundable fee as indicated above. The method of payment will be in cash. The Bidding Document shall be received, personally by the prospective Bidder or his authorized representative.

6. All Offers must be accompanied by a Bid Security in an amount at least equal to, and not lower than, a percentage of the Approved Budget Cost (ABC), in any of the following forms/terms:

a. Cash, certified check, cashier's/ manager's check	Two Percent (2%)

- 7. Submission and opening of offers shall be on (pls. see above schedule), 9:30 a.m., at Cafe 1475, Basement. Offers will be opened in the presence of the Bidder's duly authorize representative who choose to attend.
- All other provisions not indicated in the Terms of Reference (TOR) shall refer to the Latest Edition of Government Procurement Reform Act (RA 9184) or the 6<sup>th</sup> Edition of the Handbook on Philippine Government Procurement.
- The Philippine Heart Center reserves the right to accept or reject any Offer, to annul the bidding process, and to reject all Offers at any time prior to contract award, without incurring any liability to any Bidder or Bidders.
